

PRIVACY NOTICE CONCERNING PERSONAL DATA PROCESSING

Who is the Controller of your personal data?

The controller of your personal data in the scope of data provided when registering your willingness to participate in the Event is ING Hubs B.V., with its registered office in Amsterdam, the Netherlands, operating in Poland as a Branch under the business name ING Hubs B.V. Sp. z o.o. Oddział w Polsce with its registered office in Katowice, Zabrska 19, 40-083 Katowice, Tax Identification Number [NIP]: PL5263195854, National Court Register 0000702305 ("Organizer").

Why do we process your personal data?

We process your personal data for the purposes of:

- a) considering your application to participate in the Competition, your participation in the Competition and providing information related to the Competition, including the announcement of results, the issuance or dispatch of Prizes and consideration of any complaints related to the organization and course of the Competition - the legal basis for data processing is the legitimate interest (Article 6(1)(f) of the GDPR), which is to conduct the Competition in which you decided to participate;
- b) fulfilling the legal obligations of the controller in connection with the conduct of the Competition, including tax obligations, obligations resulting from the provisions of the Accounting Act – the legal basis for data processing is Article 6(1)(c) of the GDPR;
- c) to implement other legally justified interests of the Organizer, for which the Organizer considers: the possibility of pursuing or defending claims, archival purposes (evidence), to secure information in the event of a legal need to prove facts, the legal basis for data processing is the legitimate interest (Article 6(1) letter f of the GDPR);
- d) for information and promotional purposes, in particular promotion of the Competition and building a positive image of the Organiser in public space and in the media - the legal basis for processing is the legitimate interest of the controller based on the authorisation to use the image.

What are the categories of data processed?

We process the following data related to:

- a) participation in the Competition: name, surname, e-mail address, telephone number, information about education, team name, T-shirt size, food preferences, optionally image,
- b) complaints: name, surname, mailing address and telephone number, unless the complaint concerns other data.

Who do we transfer your data to?

We may transfer your data to entities to which the transfer of certain data (e.g. image) will to be necessary to fulfil the obligations arising from the Competition Regulations.

Your personal data may be transferred to public authorities and entities performing public tasks or operating at a request of public authorities, within the scope and for the purposes resulting from the commonly applicable legal regulations.

Your data may also be transferred to other entities from the ING Group (entities with capital or personal ties with ING Groep N.V. based in Amsterdam, the Netherlands), in particular ING Bank Śląski.

How long do we store your data?

We will not keep your personal data longer than necessary to achieve the goals for which they were collected or longer than provided by law, that is until the statute limitations periods elapse. In case of data processed in order to fulfil legal obligations of the controller, they will be processed until these obligations are fulfilled.

What are your rights?

You have the right to access your personal data and you have the right to rectification, erasure, the right to restrict processing them, the right to data portability, the right to object to processing, the right to withdraw your consent any time without affecting lawfulness of the processing that took place based on your consent prior to its withdrawal. Should it be found out that personal data processing infringes GDPR, you may file your complaint to the President of the Office of Personal Data Protection.

Providing your personal data is voluntary, however the marked personal data are necessary in order to get registered and to participate in the Competition.

Please be informed that we do not apply any automated decision making, and your data are not profiled.
